2009 Albany/Capital District APICS Scholarship

Deadline is April 12th!!!

For the fifth consecutive year, the Albany/Capital District chapter of APICS will be awarding two \$1,000.00 scholarships, to be presented at its annual awards dinner the evening of Wednesday, May 13, 2009. Beginning this year, scholarship eligibility has been expanded to include the general public.

To be eligible for the scholarship program, applicants must meet the following criteria:

- 1. The applicant must be a resident of the Capital District
- 2. The applicant must be a high school senior graduating in 2009 or a current full-time college student
- 3. The applicant must be accepted at or currently enrolled in an accredited two or four year college or university

Completed applications must be returned with a postmark of no later than April 12, 2009 and include the following:

- A letter of recommendation by a teacher/counselor from the applicant's school.
- An official transcript (and SAT scores if currently in HS)
- An essay of 300-500 words on the topic of "The current and future roles of Operations Management."

New APICS Corporate Membership Changes

New enterprise membership status- Effective with each organization's renewal, memberships will convert from group membership to the new enterprise membership. Enterprise membership provides organizations with many of the same benefits of group membership with enhanced options and services. With the new enterprise membership structure, corporate billing contacts are now called enterprise billing contacts (EB), while corporate voting members are now called enterprise professional members (EP).

APICS enterprise membership tiers- The changes to the structure of this membership are a result of a strong commitment by the APICS Board of Directors to strengthen membership by investing in member benefits and educational programming, both locally and at the association level. A new tiered dues structure was approved by the board in April 2008. Enterprise members may add members and save based on the number of employee members.

Tiers	Total # of Members	Total Amount Per Member

Change in membership renewal anniversary date- For streamlined processing, APICS will convert enterprise members to the same anniversary date. Each dues notice will reflect this change. Memberships expiring in different months will be prorated.

New enterprise professional e-membership option for corporate associates- As of March 31, 2009, the corporate associate category will be eliminated. Organizations with 25 or more enterprise professional members are eligible for the new enterprise professional e-membership. This e-membership is an opportunity for companies to convert active corporate associate employees to full membership with associated benefits and privileges.

This e-membership provides electronic communication of all membership benefits materials (e.g., *APICS* magazine, membership card) in lieu of hard copies. Other benefits include: Member discounts on training, registration and certification exam, Eligibility for certification maintenance points, Local chapter membership, Membership transferability within a corporation, Full membership voting privileges, Opportunity to hold elected office and serve on committees.

The dues amount for the enterprise professional e-membership is \$125 per person.

Organizations up for renewal will receive a list of corporate associates with their renewal invoice explaining each of the following membership options: Be added as enterprise professional members based on the tiered dues structure, Be converted to enterprise e-professional membership, Join as an individual professional member.

New preferred pricing option for larger enterprise organizations- In addition to the tiered structure, enterprise organizations with 150 or more paid members are entitled to participate in an APICS Preferred Enterprise Pricing Program at no additional cost. The Preferred Enterprise Pricing Program extends membership discounts on all APICS products to everyone within the enterprise organization via a promo code issued to the corporate client. The only requirement for receiving this benefit is achieving 150 members through any valid combination of Enterprise Professional Members or Enterprise Electronic Professional Members. (At least 25 of the 150 members must be Enterprise Professional Members. The remaining can be all e-members or any combination of e-member and professional.)

APICS Unemployed Membership Extension Program

If you are an unemployed APICS member whose membership is coming up for renewal and you are actively seeking work within the production and inventory management field, you may apply for an extension of membership benefits through the Unemployed Membership Extension Program.

This program enables members seeking employment within the production and inventory management industry to extend their membership for six months free of charge*. If you meet this criterion and are interested in applying for an extension of membership benefits due to unemployment, <u>download an application</u> or contact APICS Customer Support.

*Note: Members may apply for this extension up to three times for coverage over an 18 month period. Members apply for the extension through their local chapter, which must approve the request and waive chapter dues. Members approved for this waiver will receive electronic membership for the duration of the waiver, which entitles you to electronic communication of all member benefit materials.
